By completing and signing this form:

- (a) The 'Victorian Container Deposit Scheme: Supply Agreement' between the First Supplier and VicReturn will terminate under clause 11.3(a), with effect from 20 Business Days after of this form;
- (b) The First Supplier Side Deed and Accession Deed Poll to the Common Dispute Deed, will terminate on the same date as the Supply Agreement;
- (c) The Head, Recycling Victoria, will notify you with the revocation of your First Supplier Determination in writing, in due course, under section 98(5) of the Act;
- (d) VicReturn, as Scheme Coordinator, remains entitled to recover any unpaid amount owing under the Scheme Contribution and Payment Methodology following the date of termination (clause 11.5 of the Supply Agreement);
- (e) VicReturn will retain all information provided from the First Supplier for the purposes of administering the Scheme as required by the Act and any other applicable laws, subject to the confidentiality provisions in clause 13 of the Supply Agreement; and
- (f) any personal information previously provided or collected will be retained by VicReturn subject to the VicReturn's <u>Privacy Policy</u> and all applicable privacy laws.
